Group reports matters arising

GROWTH, NEW MEETINGS

Penelope: A Group Conscience during the Living Clean Meeting resulted in the idea of a new meeting. This will be a 60 minute IP Study Meeting every Thursday lunchtime (13:00). Penelope to be Chair, Lisa R to be Moderator and Charlotte to be Poster. The positions of GSR and Greeter still to be filled. Jay V agreed to post meeting on Virtual NA, Steve A arranging the room and posting on HIGNA. The first IP Study meeting will be held Thursday 1 July.

Events:

The 10 year anniversary of HIGNA is going to be on Friday 19 November 2021. Steve A informs the group that he and Ellie have been working together to come up with some designs for memorabilia items (t-shirts, mugs, badges etc) in celebration of the anniversary. A proposal will be brought to the next ASC in August.

There is discussion of holding a Speaker Jam in celebration on or around the date of the first ever HIGNA meeting. Steve plans to reach out to some of the original members of HIGNA in the hope they may want to be a part of it.

Old Business

GUIDELINES

Christine proposes we use the NA@Home Guidelines as a template for creating HIGNA guidelines. Jay V is willing to adapt the NA@Home Guidelines for HIGNA, he will bring them back to the group at the next ASC.

USE OF TRADITION SEVEN FUNDS

In relation to the subject of PI, Jay V brings up the Okanagan Group of NA - they buy Facebook Ads to target specific areas. Steve A agrees to contact Mark from Okanagan find out more about using Facebook advertisements to attract newcomers. Ellie is willing to be of service for the Facebook page in the event that this goes ahead.

Christine apologises regarding her proposal at last ASC (PI targeting Custody Suites in Scotland), she has not managed to get any further due to health reasons. Steve agrees to reach out to his contact – and to look into liaising with Scotlish Areas to find out what's going on in regards to PI in Scotland and if other Areas are already doing something similar.

Jim B, H&I Representative for HIGNA:

Tony L regarding contributing NA literature for inmates at HMP Portland. The books we contribute will be loaned out to the inmates as and when. The order includes: 6 Just For Today, 6 It Works – How & Why and 2 Living Clean at a total cost of £127. With postage and packaging at £12 that brings us to a total of £139. Tony to forward details onto Steve and he will get the order sorted out. The invoice for the books will be shared with the group.

This motion is seconded by Penelope, Ellie and Michael.

FUTURE DIRECTION OF HIGNA

Jay V brings up the future direction of HIGNA; are we going to function as an ASC? Christine proposes that we get our 'house in order' so that we can function as an ASC (every group needs a GSR, the ASC needs to be held monthly etc).

Penelope reports that is similar to the conclusion the Living Clean group came to; we are a collection of groups but not attached to an area we would be accountable to. It seems to be a good idea to put our energies into attracting more newcomers.

Jay V remarks that HIGNA functions as a 'Meeting House' at this point.

After a very full discussion it was decided that we continue what we are doing and work on getting stronger. The groups have asked if Steve A would approach Region again (re: What is their position on virtual service groups attending region?) and he is willing to do so.

Penelope seconds this proposal. There are no objections.
