A small workgroup has been put together, consisting of Steve A, Michael B, Penelope, Lisa R and Spider. We now have a point of contact with UKPI and an offer has been made from the Chair of UKPI to do the opening part of any workshop HIGNA engages in.

TRADITION SEVEN FUNDS

There is a suggestion to use some Tradition Seven funds for an introductory pack of Public Information literature to give to Orkney ADP. Steve A is to contact UKPI to ask their opinion on sending this to the Orkney ADP, prior to them having the discussion in April about HIGNA doing the presentation for them later in the year.

In regard to making a contribution to Region: HIGNA won't make any contributions until Michael B gets a definitive answer from Region and we get the full Forensic Treasury Report (with what's been happening with money at Region over the last two years).

Debs requests that HIGNA increase the Prudent Reserve by £100. It is currently £500 which covers 2 years' operating expenses. No decision is reached by the Committee at this point, it will be discussed at a future ASC.

FUTURE DIRECTION OF HIGNA/ PI & H&I REPS?

There is an individual willing to set up an H&I meeting on HIGNA. It is a very new idea, and not ready to start just yet.

New Business:
