Ongoing question re status of Region Treasury, the September Treasury report has been made available on the HIGNA TS WhatsApp Group and or can be seen on this link: https://sites.google.com/view/sw-london-rcm-info/home Web tech was able to provide some clarity re the current position of the RSC Treasury and process. Question raised re sending contributions direct to EDM, RCM to seek clarification re current RSC policy on this. Motion to make a £200 contribution to the November RSC at this time, motion seconded and carried by consensus. Question re running expenses, A, please refer to the annual expenditure details as included in the Area Treasury Report.

New Business:

Printing of National WTF: UKNA Meetings Data base now makes it possible to print localised meetings lists direct as a PDF. Clarity was provided re UKSO and Region policy on printing WTF's. Discussion was had re HIGNA's position as an an online service and printed WTF's. Proposal was made and carried that we ask the RCM to carry a HIGNA consensus not to print National WTF's at the next RSC.

A Devon Group of 7 autonomous virtual meetings is in conversation and thinking to join HIGNA. Was raised that a HIGNA policy was set in 2020 to welcome any virtual groups wishing to join us and that, as such, that policy still stands. Discussion was had around the structure of the Devon Groups. Consensus was reached that given the ongoing nature of the Devon Groups deliberations the issue was left open and the RCM was mandated to let them know they are welcome if they choose to join us.
