In regards to an online presence with H&I in the UK, a pilot has been rolled out called 'Visionable'. This has been accepted for use by prison services across the UK. There are a number of prisons using it. It is highly secure, and prison officials are happy with it. There are regularly scheduled meetings being brought into the prisons in the UK.

"Literature was sent through NAWS, a 33 page e-book especially written by young addicts for young addicts. The document is ready for publication pending approval from the body. This booklet will be EDM approved literature not WB approved. Booklet has been approved and is now available to download. The e-book can be found in the March 2023 RD Folder." (From March Region Action List) Jay V has a question regarding this new piece of literature (for young people, by young people) being approved by the European Delegates Meeting (EDM). Jay is concerned that EDM is creating, producing and approving literature, when it is normally approved by the Fellowship. Jay brings up the issue that literature can't be written locally for one place and not for others. It needs to be a level playing field. If EDM can suddenly write their own literature, then we should all be able to write our own literature.

It is decided that more clarity on this is required. Michael B is to get some clarity on the process and will report back to the group at the next ASC.
